# Sexual Assault Exam Reimbursement: What does law enforcement need to know?

## Background

The investigation of a sexual assault can be a daunting task for even the most experienced investigator. Collaboration with medical professionals can positively influence the investigation and ensure accuracy. Numerous recent, major developments have significantly impacted the law enforcement agency (LEA) investigation of, and health care response to, sexual assault in Texas. Several statutory changes occurred during the 85th (2018) and 86th (2019) legislative sessions. Also, the release of the updated <a href="Texas Evidence Collection Protocol">Texas Evidence Collection Protocol (Charles et al., 2019)</a> may alter the patrol officer's or detective's response to sexual assault.

### Evidence Collection Timeframe Extended to 120 hours

House Bill 616 amended the Code of Criminal Procedure 56.065 by extending the sexual assault evidence collection time frame from 96 hours to 120 hours (five days). Therefore, refer all persons who report sexual assault within the last five days to a medical facility that provides post-sexual assault health care. Best practice is to refer all suspected sexual assault survivors, regardless of the type of contact or penetration reported. Survivors may not feel comfortable to disclose the entirety of what occurred to law enforcement. They may feel more comfortable discussing what occurred with health care professionals. LEAs may also wish to consider completing examinations of suspects of sexual assault. Many forensic nurse programs will collaborate with LEAs to complete suspect medical forensic examinations.

## Reimbursement for Forensic Medical Sexual Assault Examinations

House Bill 616 also changed the process for reimbursement of forensic medical sexual assault examinations. Prior to September 1, 2019, LEAs paid health care facilities for completing the forensic medical examination of people who reported sexual assault. LEAs then requested reimbursement from the Office of the Texas Attorney General (OAG). Effective September 1, 2019, health care facilities can directly bill OAG, but the Attorney General Law Enforcement Request for Sexual Assault Exam form must accompany the bill.

## Mandatory Notification for Sexual Assault Examinations

People who report sexual assault to a LEA now shall be notified by said LEA whether a forensic medical examination was requested or denied. House Bill 616

mandates that LEAs shall document, utilizing the Attorney General Law Enforcement Request for Sexual Assault Exam form, whether the agency requested a forensic medical examination.

The LEA shall provide the form to:

- 1. The victim
- 2. The health care facility and the sexual assault examiner

Then maintain a copy of the form at the agency.

The form is required in order for the health care facility to request payment from the OAG. This form does not need to be completed by a supervisor; it can be completed by a patrol officer.

## Updated Texas Evidence Collection Protocol & Sexual Assault Evidence Collection Kits

The Texas Evidence Collection Protocol was also updated. The Office of the Texas Attorney General and Texas A&M University Center of Excellence in Forensic Nursing partnered to formalize the standardized guide for any professional who comes in contact with survivors or suspects of reported sexual assault. An advisory board of 22 subject matter experts, including three law enforcement experts, was formed to revise the protocol. The web-based resource reflects the latest best-practices and evidence-based research, and can be printed on demand. Additionally, the sexual assault evidence collection kit (SAEK) contents and forms were updated to reflect best-practices in DNA evidence collection and preservation.

#### Sexual Assault Evidence Tracking




House Bill 281, in the 85<sup>th</sup> legislative session, amended the Texas Government Code

420.034 mandating Texas Department of Public Safety (DPS) begin tracking sexual assault evidence effective September 1, 2019 so sexual assault survivors could track their SAEK throughout the process. DPS partnered with STACS DNA, Inc. to create the Track Kit online portal. SAEKs are now tracked from the manufacturer to prosecution. Each professional along the process, enters data in Track Kit. Health care professionals, LEAs, and prosecuting attorneys must participate in Track Kit. The sexual assault survivor, however, may consent or decline to participate in Track Kit.

#### Timeframe for Possession of SAEK

House Bill 8 amended the Government Code 420.035 such that the health care facility shall immediately notify LEA that a SAEK requires pick up. Effective September 1, 2019, LEA have seven days to take possession of the SAEK, unless they are located more than 100 miles from the health care facility. These significant changes to Texas statutes greatly impact the health care and law enforcement response to sexual assault. However, collaboration between professionals ensures the law enforcement officer completes the best investigation of sexual violence.
