The degree to which a victim will recover is in high correlation to their level of resilience, human trait we are as of yet unable to measure. No two people will have exactly the same response to their personal trauma. Victims lose their sense of self, feel they have no identity and are undeserving of help. They are ashamed, sick & beaten down, fearing everyone, unable to trust and suspicious in all circumstances, as if waiting for the inevitable other shoe to drop. Some, overwhelmed by the fact of a new reality, may be inclined to go back to an environment they've grown used to and feel they can better manage. Those who have become drug and alcohol addicted will struggle with their addictions, perhaps for the rest of their lives.

Having been denied choice in anything, victims find it difficult to make decisions for themselves, fearing harsh punishment if they make mistakes.

While this may give the impression trafficking is restricted to a particular "group" in society, we are becoming ever more aware that human slavery is no respecter of persons, position or power. Vigilance and effective penalties will, of course, be key to helping overcome this enemy - keeping the issue in the public eye will amplify effectiveness. Meanwhile, healing can come. Treating survivors is a process requiring patience, commitment, compassion and - dare I say it - funding.

What is Peer Support? By definition, peer support is getting help from someone who has been through similar situations, illnesses, etc. People that have similar experiences may be able to listen, give hope, and guidance toward recovery in a way that is different, and may be just as valuable as professional services. In addition to the direct services one may receive, many peer-run organizations advocate to improve opportunities for people recovering from mental illnesses. Peer support programs like River City Advocacy, Inc. strengthen primary care practice and community health by reaching the vulnerable populations and reducing health disparities.

RCA has worked with numerous survivors of assault, domestic violence, and other abuses through peer support and individual counseling as well as our Boundaries workshop. It is important for the survivors to

come from thinking of themselves as being a victim to being a survivor to help them begin their healing and recovery journey. There are many times that we are called upon to work with families in crisis centers, shelters, and the court system. Our goals are to help them learn more about themselves and healthy relationships, including setting and maintaining proper boundaries.
